

## KTM/Husaberg Spark Arrester End Cap Installation Instructions

**1** Using an 8mm socket, remove the 2 mounting bolts on the side of the silencer; pull the silencer back and off of the exhaust pipe.

**2** Using the supplied 3/16" drill bit, drill out the four rivets holding the stock end cap in place. (Fig 1) You may need to use a small punch to drive the rivet free from the hole (Fig 2)

**3** Reinstall the silencer on the bike.

**4** Using a wooden or plastic handle, slip the end of the handle in the end of the stock cap and wiggle the stock cap free from the silencer. (Fig 3)

**5** Remove the stock end cap (Fig 4)

**6** Next, push the stock packing in about one inch to allow room for the Enduro Engineering end cap base. (Fig 5)

**7** Install the base of the Enduro Engineering end cap (Fig 6), make sure the drain hole is located at the bottom of the silencer (Fig 7)

**8** Install the supplied four torx head bolts through the body of the silencer and in to the end cap base. (Fig 8)

**9** Install the Spark Arrester screen with the bubble out in to the end cap base. (Fig 9)

**10** Remove the rubber o-ring from the stock cap and install it on the Enduro Engineering cap (Fig 10)

**NOTE:** It may help to stretch the o-ring slightly to make installation easier.

**11** Using a 4mm Allen wrench, install the two supplied Allen head bolts. (Fig 11)
