## **Skid Plate Installation Instructions**

<sup>1</sup> Hook the 1 supplied rear clamp over the rear cross section part of the frame as shown in **(figure 1)**.

<sup>2</sup> Insert the front attachment bar over the top of the frame as shown in (figure 2). The machined flat should face the engine.

<sup>3</sup> Hold the skid plate in place and start the 2 front 8 x 40mm mounting bolts. These bolts screw into the front attachment bar as shown in (figure 3). Do not tighten bolts yet.


<sup>4</sup> Now start the shorter 8 x 20mm mounting bolts in the rear. In (figure 5) you will see that the skid plate has four holes, on the linkage bikes you will us the center 2 holes and the non linkage bike the outer 2 holes. These bolts screw into the rear clamps as shown in (figure 4). Do not tighten bolts yet.








<sup>5</sup> Make sure the skid plate is well centered then tighten the front and rear mounting bolts using a 5mm Allen wrench.
