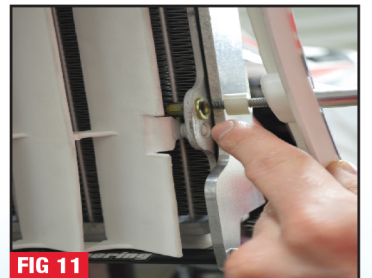
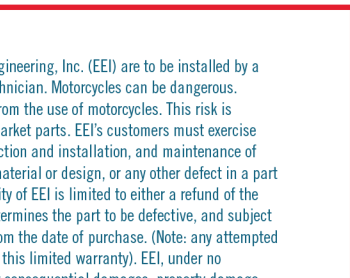
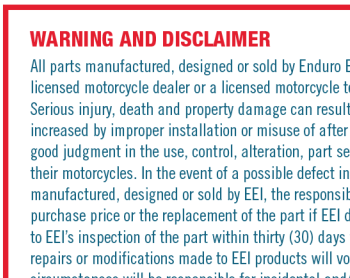
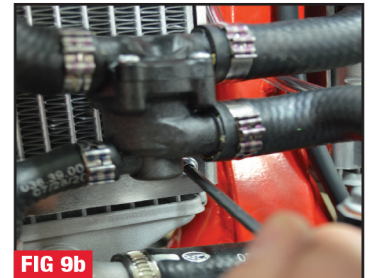
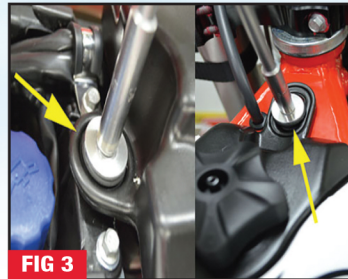


Radiator Brace Instructions-Beta

- 1** Remove the seat by pressing the button on the left towards the rear of the motorcycle (fig. 1)
- 2** Remove the tank and shrouds.
 - 2a** Turn off the fuel valve, and disconnect the fuel lines.
 - 2b** Remove the two lower shroud mounting bolts (fig. 2)
 - 2c** Using an 8mm socket remove the two bolts securing the tank (fig. 3)
- 3** Remove the plastic radiator louvers (fig. 4)
- 4** Using an 8mm socket remove the two radiator mounting bolts (fig. 5)
- 5** Using the supplied M6x16mm button head bolts fasten the radiator rods to the piece labeled 402R/L1 (right or left side) (fig. 6)
- 6** Install the assembly from the previous step between the radiator and the frame (fig. 7)
- 7** Using the provided M6x16 hex head bolt, 22mm washer and spacer fasten the radiator and brace to the frame (fig. 8)
- 8** Connect the outer radiator brace labeled 402R/L2 (right or left side)
 - 8a** Use the provided M6x8mm button head bolts to connect the back side of the radiator brace (fig. 9a & b) (combine both into one if possible).
 - 8b** Use the provided M6x16mm button head bolts to secure the radiator rods (fig. 10)
- 9** Complete steps 3-8 on both sides of the bike if not already done so.
- 10** Put the radiator louvers back on the bike (fig. 4).
- 11** Put the tank and shrouds back on the bike.
 - 11a** Use the provided nylon spacers and 25mm bolts to secure the lower shroud to the radiator. (fig. 11)
 - 11b** **NOTE:** you may need to loosen all tank and shroud mounting bolts to align the lower shroud mounts.
 - 11c** Use the OEM hardware for the two tank mount locations.
 - 11d** Be sure to reconnect the fuel lines.
- 12** Put the seat back on.
- 13** Have fun and ride safe!
