EE Installation Instructions

- Remove the air box cover (fig. 1).
- 2 Using a 10mm socket remove the 8mm bolt for the 0EM chain guide (fig. 2).
- 3 Using an 8mm socket remove the three 6mm bolts for the slave cylinder and OEM chain guide (fig. 3).
- Connect the supplied 8mm clip nut to the knockdown bar as shown (fig. 4).
 - 4a NOTE: Be sure the threads of the clip nut are on the same side as the "016" part #.
- 5 Using the supplied M8x55mm hex head bolt, fasten the provided spacer, chain slider and knockdown bar as shown (do not tighten at this time) (fig. 5).
 - **5a NOTE**: be sure the opposite side of the knockdown bar is positioned as shown (**fig. 6**).

- 6 Using the provided M6x40mm hex head bolts, mount the clutch guard over the slave cylinder and wire (fig. 7).
 - 6a Make sure the wire is positioned within the clearance area inside the clutch guard.
 - **6b** Push the slave cylinder guard and slave cylinder up against the engine cases with your hand.
 - **6c** Align the 3 bolts in the slave cylinder guard and tighten the three bolts in a star pattern to ensure a square fit.
- **7** Refer back to step 5 and tighten the 8mm bolt at this time.

7a NOTE: Make sure the chain slider is rotated up against the air box (fig. 5). It is normal for the slider to be horizontal or even slightly angled down (fig. 5.1).
